A Poetical Testimonial to the Benefits of Alden's Black Water Baths

The first Black Water Bath House opened in November 1904. People came from all over the eastern United States to soak in the mineral rich water. Two other bath houses joined the Original (now St. Aidan's Church)—one on Exchange Street and one on the north side of Main Street. It was said that 75% of the patients were cured and 90% were benefited from the recommended twenty-one baths treatment. The last of the bath houses closed in 1965.

As I was telling a friend how I suffered with rheumatic pain,

Now as he has taken a course of treatment there
I thought it to be only just and fair
To allow that with his experience he probably knew
As to whether all his statements were true.

So I considered them over and took his advice
And said to be cured I would be willing to go twice.
Then I packed up and started as soon as I could
And when I got there found the people kind and good.

Everything around was clean and neat,
And at the table we had of the very best to eat.
It was cooked and served in the best of way
And no one need go hungry during their stay.

A few baths made them feel better, I knew it by hearing them talk;
And in a few more days they would shoulder their crutches and take a walk.
They would not go far before casting theirs along the road,
And I am told that village boys gather them up by the load.

Each day while there I was given a good bath,
And very soon found I was on the right path;
I gained so fast that in a very short spell
I got to feeling so good that I knew I was well.

When starting for home I was invited to take a free bus,
And of course I accepted without any fuss.
Now right there I wish to say (if the owner does not mind)
That it was one of the very, very best of its kind.

As I pondered it all while at the depot
Right back to the hotel I was tempted to go;
Then realizing that I ought to refrain,
As soon as it arrived I got on the train.

While homeward bound and as we glided along
It got impressed on my mind very, very strong
That if ever again in my life I saw even one sick day
I would pack my grip and take the first train that way.

I tell the truth, I was in my sixty-eighth year,
But that now I am much younger to me is very clear
So to prove to you how much younger I must feel
I will inform you that I have just bought my first automobile.


And as to its being one of the best there is no mistake,
For it is a special six of the Studebaker make;
Now when I wish to go to Alden, whether in sunshine or rain,
I can get in my car and not have to wait for any train.

The treatments while there make me feel so sublime,
So not being a poet I have tried to write this in rhyme;
And remembering that when I started for home there were many nearby,

Historical Society Bake Sale Cancelled, Launches Fund Appeal

Two Bicentennials in the Offing

Yes, not one, but two bicentennials coming soon. The first is the bicentennial of Erie County beginning in April 2021. Before 1802, all of New York State, west of Seneca Lake, had been Ontario County, except for the part taken off to create Steuben County. In 1802, Joseph Ellicott, surveyor of the Holland Purchase, persuaded the New York State Legislature to create Genesee County out of all the land west of the Genesee River. In 1806, land of Genesee County was taken off to create Allegany County. By 1808, the residents of the rest of Genesee County felt there were enough of them to justify further subdivision.

In March of 1808, a law was enacted that all the land north of Cattaraugus Creek and west of the line between fourth and fifth ranges of townships (Darien is in Range 4, Alden in Range 5) should form Niagara County. The counties of Cattaraugus and Chautauqua were formed at the same time, but remained in Niagara County until each had 500 voters. The land north of the center of Tonawanda Creek were formed into the Town of Cambria; all that part between Tonawanda Creek and the center of the Buffalo Creek Reservation became the Town of Clarence, including the then Village of Buffalo.

By the census of 1820, the population of the whole of Niagara County was 23,313, a number considered sufficient enough to justify a division. On April 2, 1821, a law was passed enacting that all that part of Niagara County north of the center of Tonawanda Creek should be a separate county called Niagara; the remainder would be known as Erie County.

Just two years later, on April 1, 1823, the New York State Legislature created the towns of Alden and Erie (later changed to Newstead to avoid confusion with an earlier Town of Erie) out of the Town of Clarence.

Plans are being made to celebrate Erie County 200, within the restrictions of the pandemic, and a committee is being formed to celebrate Alden's 200th birthday in 2023.

The Story of Erie County

In **1772**, the present **ERIE COUNTY** was part of **ALBANY COUNTY**, of New York Crown Colony.

From **1772 to 1789**, the present **ERIE COUNTY** was part of **TRYON COUNTY** which in **1784** was changed to **MONTGOMERY COUNTY**, New York

From **1789 to 1802**, the present **ERIE COUNTY** was part of **Town of Northampton, ONTARIO COUNTY**, New York.

From **1802 to 1804**, the present **ERIE COUNTY** was part of **Town of Batavia, GENESEE COUNTY**.

1804-1808-that part of present **ERIE COUNTY** in the 7th, 8th, 9th and 10th ranges of the Holland Land Company's survey (area west of the West Transit Line or present Transit Rd.) was part of the **Town of Erie**, Genesee County.

1804-1808-that part of present **ERIE COUNTY** in the 5th and 4th ranges of the Holland Land Company's survey (area east of the West Transit Line or present Transit Road) was part of the **Town of WILLINK**, Genesee County.

In **1808**, the **COUNTY OF NIAGARA** was created, consisting of that part of Genesee County west of the 4th range of the Holland Land Company's survey and north of Cattaraugus Creek.

In **1821**, the **COUNTY OF ERIE** was created, consisting of that portion of the **COUNTY OF NIAGARA** west of the 4th range of the Holland Land Company's survey, south of Tonawanda Creek and north of Cattaraugus Creek.

Business Member Spotlight—Cooke and Steffan, Attorneys



The building housing the law office of Cooke and Steffan at 13132 Main Street has a long history from being part of the George Bentley farm (now the Alden Memorial Town Park,) to an Italian-American restaurant and hotel, the Green Tavern Hotel, owned and managed by Frank Gaetano in the 1930s, to law offices for Richard T. Cooke and Edwin F. Steffan in the 1970s. A US President's name appears on the title to the property—Grover Cleveland—who sold the property, albeit in his role as Sheriff of Erie County.

Today, the law office is owned by Thomas Steffan, a nephew of Edwin Steffan. It is a full service law firm dealing with real estate closings, divorce, estates, wills, estate planning, business formation, bankruptcy and Medicaid planning.

History Repeats Itself 1918—1921



IMPORTANT TO THE PUBLIC.

The following instructions were issued yesterday by Dr. Edward A. Latham, local officer of the State Board of Health, and Dr. L. M. Powers, City Health Commissioner:

TO AVOID INFLUENZA.

1. Avoid the person who coughs or sneezes without covering his mouth and nose with a handkerchief.
2. Avoid the person who spits where it will spread disease. He is dangerous as well as indecent.
3. Avoid crowds. They multiply your chances of catching influenza.
4. When you cannot avoid crowded places keep your mouth shut and breathe through your nose.
5. If you see a person with red, watery eyes who is sneezing or blowing his nose stay away from him.
6. If any of your friends have a cold or are sick with influenza, do not associate with them.
7. Stay out of doors as much as possible. As long as you avoid crowds it is far better to go for a walk in the evening than to call on a friend or go to the theater.
8. Keep all of your rooms well ventilated.
9. Avoid getting chilled when you are warm from work or other exercises.
10. Avoid dusty places. Dust irritates the nose and throat and makes it easy for you to catch influenza.
11. If smoking irritates your throat stop it for the same reason as above.
12. Drink plenty of water.
13. Eat enough, but not too much.
14. Keep your bowels open.
15. If you wish to use additional precautions ask your doctor.

IF YOU CATCH INFLUENZA.

1. If you feel feverish and have a headache, backache, or cold in your head, consult a doctor at once.
2. Stay in bed until you are absolutely well—at least three days.
3. If you have influenza or any cold, avoid giving it to your family, friends and others.
4. Never cough or sneeze without covering your nose and mouth with a handkerchief.
5. Do not spit on sidewalks, floors, street cars, or places where germs will spread.
6. Boil your handkerchiefs after they are washed.
7. Keep your rooms well ventilated.
8. Eat enough plain food, but not too much.
9. Drink plenty of water.
10. Keep your bowels open.

The 2020 Alden Chamber of Commerce Ornament

When asked to suggest a business or organization for the 2020 Chamber ornament it seemed imperative to highlight one that stood out during this pandemic year, but there were so many, and so many of those had already been honored with an ornament.

Being a former teacher, I have said numerous times during the year, "I'm so glad I'm retired. I don't think I could do what they are doing." "They" being the faculty, staff and students of the Alden Central School District, including St. John's. In their honor, I suggested the Henskee Road Schoolhouse for the ornament.

The schoolhouse once stood on the south side of Henskee Road, just over the eastern border of the Buffalo Creek Seneca Reservation, across from the Henskee-Foss farm. It served the families living on Exchange St., Henskee Rd., and Sullivan Rd.

It is representative of the schoolhouses that dotted the landscape of the town before centralization. It is also representative of the difficulties overcome by the teachers and students of those schoolhouses: all eight grades being taught in one-room by one teacher, insufficient heat, no electricity, no running water; yet the students learned and became productive citizens.

The teachers of 2020 learned to teach remotely, and the students learned. The food service staff continued to feed the children with the help of the transportation staff. The maintenance staff began deep-cleaning the facilities and making plans on how to do that when the students returned to the classrooms. The 2020 Chamber of Commerce ornament salutes you all.
